There is no cost to attend the programme. The selected candidate will attend all four sessions held in 2023. (i.e. February / May / September / November).




INSOL FUTURE LEADERS OF BERMUDA

22 FEBRUARY 2023 PROGRAMME

The first in the series of INSOL Future Leaders programme will be held on 22 February 2023. The programme for the session is below. Further information on the three proceeding sessions will be provided at a later date. Participants are expected to attend all four events.

2:00pm - 2:15pm: Introduction to the INSOL Future Leaders Programme.

2:15pm - 3:15pm: Differences between solvent and insolvent liquidations; Initial conduct of an insolvent liquidation from a liquidator's perspective.

3:15pm - 3:45pm: Initial conduct of an insolvent liquidation - from a lawyer's and court's perspective.

3:45pm - 5:00pm: Coffee Break

4:00pm - 5:00pm: Case study - participants will role play the role of the liquidators and lawyers in seeking relief for pursuing the liquidation of a Bermuda reinsurance company with creditors in Bermuda, England, and the US, Topco in the US, and subsidiaries in the US and England that provide internal administration services. There are antagonistic directors residing within and outside of Bermuda who are not willingly providing any information in relation to the company or its subsidiaries.

Students will participate in smaller groups, mentored by a seasoned professional, and will consider a range of issues including, but not limited to, the procedural steps of an official liquidation, gaining access to books and records, taking control of assets in foreign jurisdictions, foreign recognition of an official liquidation and the dissolution of a company.

5:00pm - 6:00pm: A cocktail unwind reception laced with nuggets of wisdom from seasoned practitioners who will share important life lessons which they have paid for by their experiences, good and bad. They will answer questions and share tips on what practitioners look for when determining who they will work with. They will also share tips on money management and dealing with stress factors that challenge mental and ethical wellness.
